

Of the \$7,070,801.00 in LCFF Funds, \$1,558,365.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

In 2023-24, Diego Valley East Public Charter is projecting it will receive \$\$1,558,365.00 based on the enrollment of foster youth, English learner, and low-income students. The Local Control Accountability Plan (LCAP) directs the Supplemental and Concentration funding into goals and actions designed to help high needs students with social-emotional support, academic interventions, counseling and student engagement activities. Students have access to a robust tutoring program that supports their learning. Targeted academic interventions help close skill and knowledge gaps ensuring that students become competent graduates. Our second goal is a broad goal supporting student interest in a career or a higher education. The third goal is a maintenance of progress goal that meets the mission of our school program, which is to retain students and help them graduate. 

Diego Valley East Public Charter actually spent \$1,409,836.00 for actions to increase or improve services for high needs students in 2022-23.

The difference between the budgeted and actual expenditures of \$341,996 had the following impact on Diego Valley East Public Charter's ability to increase or improve services for high needs students:

Students in our independent study program were able to benefit from fully funded intervention programs like tutoring. Additionally, English learners, foster youth and special education students were able to receive socioemotional support with counseling services and trained staff. Our student retention staff were fully funded and able to help provide interventions and outreach to support our students' regular attendance.

## Plan Summary [2023-24]

## **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Diego Valley East is an independent study school that is a part of the Dashboard Alternative School Status (DASS) program. The school serves a diverse student population to engage all students in learning. The enrollment of DVE as of CBEDs day 2022 was 411 students, and the school serves 23% English Language Learners, 83.7% low-income, 0.004% foster youth, and 21% special education students. DVE provides students with a personalized education in an alternative setting. The goal is to successfully prepare students for college and careers through job-readiness courses, standards-based coursework, and workforce partnerships. Through partnerships with WIOA, students will have improved tools to identify and access training options and other employment services that best suit their needs. Many students need the flexibility of an independent study program to meet the needs of their family obligations, work, and childcare needs. Since DVE serves diverse students, many are English Language Learners and low income. Some students have been unsuccessful in the traditional seat-based school environment and seek an alternative to their education. DVE offers choices through site-based learning, independent study, and distance learning to enable all students to learn and make a difference in their lives.

The school provides a diverse, student-centered learning environment where all students are held to high academic and behavioral standards. The school encourages parental involvement, one-on-one teacher-student interaction, student-driven participation in the learning process, student curriculum choice, and technology access. The personalized learning model is tailored to meet the needs and interests of each student. Each student has an academic plan that includes coursework to optimize their learning potential and success. The school utilizes multiple assessment platforms to measure student academic achievement. The assessment platforms include reviewing learning records, student work samples, and state assessment data. The school provides a personalized learning approach to enable students to

become critical thinkers, determined, self-directed, and lifelong learners. DVE is a year-round credit recovery program with 13 Learning Periods (LP) to structure the academic year.

DVE has 31 employees: fourteen are teachers, four education specialists, three tutors, two paraprofessionals, one school counselor, four operations members, one student retention support, and one assistant principal.

The 2010 United States Census reported El Cajon to have a population of 99,478. El Cajon comprises 42% white, 6% African American, 1% Native American, 4% Asian, and 30% Hispanic. Approximately one-third of the population was born in another country. Chaldean and Arab immigrants make up the largest communities in the country. El Cajon has the highest poverty rates for San Diego County among adults, 30%, and children, 37%.

The 2021-22 School Year was the first year DVE accepted Title 1 funds. In 2022-23, DVE became a Schoolwide Title 1 Program. The use of the Title 1 funds are described in this LCAP, in order to meet the School Plan for Student Achievement (SPSA) requirements. The Title 1 funds may be used to supplement the strategic plan directed at helping our at-risk students meet state standards and graduate. We are using the LCAP to fulfill the planning requirements for Comprehensive Support and Improvement (CSI).

### **Reflections: Successes**

DVE analyzed the school data from the CA Dashboard, DataQuest, SARC Report, LCAP Annual Data Report, and the WASC Action Plan, all which align with the eight state priorities. Although the school is identified for Comprehensive Support and Improvement (CSI), due to the federal graduation rate, significant successes were shared in the following key metrics below.

#### Graduation Rate

The CDE calculated the Dashboard Alternative School Status graduation rate at 86.3%. This graduation rate is an increase of +2 percentage points from the previous year. English Language Learners graduated at 82%, and Hispanic students at 80%. The socioeconomically disadvantaged students graduated at 82% last year. DVE plans to increase the success rate with each student group by increasing, supports such as tutoring, for all seniors.

#### Success Rate

Another important measure for DVE is the success rate, which is the percentage of students who graduate, and the percentage that are retained or returned to their local school district. The success rate is 90.3% up six percentage points. The success rate is the highest it has been in three years and shows that the mission of meeting a student's academic and social-emotional needs continues to be effective.

#### **Retention Rate**

One critical focus of the program is to improve the performance of disengaged students and address their social-emotional needs. DVE identifies, early on, which students need to complete their schoolwork and assigns the student additional support, such as tutoring. The retention rate improved by +9 percentage points to 84.3%. An Increased retention rate is due to the collaborative teamwork between our teachers, tutors, and counselors.

#### Attendance

The attendance rate is up by +10.77 percentage points to 90.75%. DVE believes that the re-engagement strategies implemented to help students and families during COVID-19 increased the student's average attendance rate. The teachers and retention support staff worked to address the serious concerns the school had about students dropping out. Building relationships and staying connected to students decreased the non-completer rate by 3.8 points to 9.65%. The increased attendance rate means the school improved on keeping students enrolled and attending regularly.

#### Credit Completion

The credit completion rates increased over the last two years. With additional supports in place, such as tutoring, the students could earn, on average, +19% more credits at the same time last year. The English Language Learners achieved a +10% higher credit completion rate than the All Group. Students in the socioeconomically disadvantaged group had about the same credit completion compared to the All Group.

#### Suspension Rate

The suspension rate was rated "Very Low" on the CA Dashboard. The suspension rate was 0% Homeless students were in the very low range, and Hispanic and socioeconomically disadvantaged students also had 0% suspensions. There were no expulsions.

#### School Survey Results

The school survey data showed that 98% of the students felt connected this year. Face-to-face interaction with a caring adult will help students feel connected. Ninety-nine percent of the students surveyed said that they feel safe at school. Ensuring the students have the appropriate time and attention to succeed in school is essential. Teachers reported that 100% felt safe and 100% felt connected to the school. DVE has high expectations for school safety and connected, and we intend to continue to improve the school connectedness.

#### The College/Career Indicator

The College and Career Indicator was suspended for 2022. It was not reported for last year on the CA Dashboard because it requires two years of data for a calculation. Next year it will have a status report.

How will we maintain our success?

DVE plans to maintain and build on the success by implementing the LCAP actions to fidelity, carefully monitoring the progress, and discussing the results within the professional learning community. DVE will continue to grow in capacity as we engage in continual improvement based on the Plan-Do-Study-Act model. Data discussions with teachers and administration will be grounded in learning community protocols to improve performance on student outcomes.

The goals and actions articulated in the LCAP support the individualized learning model, and adequate funding ensures that effective strategic supports such as tutors, student retention services, and trauma-informed trained teachers continue. DVE monitors student progress through multiple measures around engagement and academic performance. The LCAP and other local data are discussed quarterly and shared with educational partners, including the school board.

Due to the nature of DVE's credit recovery, independent study, and Dashboard Alternative School Status program, specific data points are not included in the LCAP. Rarely do students take Advance Placement exams or the EAP. The federal calculation for the 4-5 year cohort graduation rate and the chronic absenteeism rate is also not a match for the program because the measures are for seat-based programs and not short-term independent study programs with high mobility students. DVE utilizes alternative metrics such as the one-year DASS graduation rate and local attendance rates to monitor and report the student's progress towards graduation. Furthermore, our dropout rate is calculated as our non-completer rate, which tracks any student who does not report to DVE that they have continued with another program to complete their education.

## **Reflections: Identified Need**

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The school was identified for Comprehensive Support and Improvement (CSI) due to a low federal 4-5 year cohort graduation rate. The identified needs section describes how DVE will meet the federal requirement for CSI. DVE used state and local metrics to identify student groups' performance gaps and resource inequities. The school used student outcome data from the latest CA Dashboard, DataQuest, CALPADS reports, and local LCAP data tracking to address areas of improvement within each goal and action of the LCAP. The internal data collection are aligned with state indicators and local performance indicators. DVE regularly monitors and evaluates the identified outcomes so that the school can adjust to areas that require improvement. As a professional network, DVE used a fishbone protocol for the needs assessment around the low graduation results. The fishbone revealed that multiple causes play into the graduation rate that needs to be managed, such as credit completion, attendance, student motivation, parent engagement, and tutoring. The school data demonstrates that DVE will need to improve in graduation (5-year cohort), EL reclassification, and academic indicators by increasing tutoring for students not in line to graduate.

State performance indicators from the California School Dashboard show the following indicators were low or very low:

#### 5-Year Graduation Rate:

The federal 4-5 year cohort graduation rate was very low and qualified DVE for CSI. The 5-year graduation rate was 21.7% in 2022. This graduation rate is far below the 68% threshold. The student group data used in the analysis is from the 2022 Dashboard and is reported in DataQuest. The lowest performing student group was the homeless student group 15% and Hispanic students at 18%. English Language Learners at 24%, and the students with disabilities graduated at 20%. These groups were 1-6 points below the All student group. The socioeconomically disadvantaged students were at 20%. The African American student group was highest at 27%, and all other groups were between 2-17 points below. DVE recognizes the inequities between the highest and the other student groups. The plan to address the gap in graduation scores is outlined in our CSI plan in the LCAP.

#### CA Dashboard English Language Arts

The Academic Indicator for English Language Arts showed 71.7 points below standard and received a low status. The socioeconomically disadvantaged student group scored 81 points below standard, while the Hispanic student group scored 49 points. Hispanic and socioeconomically disadvantaged students had a very low status and were about 20 points below the All group. African American, White, Asian, English Language Learners, homeless, students with disabilities, and other student groups did not have enough students for a valid calculation. However, DVE knows they are low because of their NWEA diagnostic scores. The school serves students who are traditionally 3-4 grade levels behind. Most of the students come deficient in credits and skills, and they score at the 7th-grade level in ELA.

#### CA Dashboard Mathematics

The Academic Indicator for Mathematics for the All student group was 182.1 points below standard and received a very low status. The socioeconomically disadvantaged students scored 186, and the Hispanic students scored 153, rated very low. African American, White, Asian, homeless, foster youth, English Language Learners, and other student groups did not have enough students for a valid calculation. DVE knows from their NWEA diagnostic assessments that they are low as well. Students who enroll with DVE are typically 3-4 grade levels behind in their schooling.

No student groups were two or more performance levels below the "all student" group. In most cases, the performance levels among all groups were the same for the graduation, ELA, and mathematics indicators.

#### English Learner Performance Index

The English Language Learner Performance Index shows 31.8% making progress, based on their ELPAC scores. ELPAC growth is low. DVE is working towards moderate growth. The English Language Learner reclassification rate decreased from the previous year by one percentage points and is at 6% this year. The reclassification rate is reasonable because DVE expects it to exceed the CA average of 8.6%. However, the English Language Learner progress is important for Goal 1 Action 1.

## **LCAP Highlights**

The Local Control Accountability Plan (LCAP) provides funds for helping high-need students with social-emotional support, academic interventions, counseling, and student engagement activities. Students have access to a robust tutoring program that supports their learning. Targeted academic interventions, such as tutoring, will help close the skill and knowledge gaps, ensuring that students become competent graduates.

The following LCAP Goals support the low-income, English Language Learners, foster youth, special education, and all students:

- Goal #1: Increase Academic Progress

- Goal #4: Increase Educational Partner Engagement

The first goal has the highest priority and is a focus goal, with actions directed at helping the unduplicated students improve their performance, especially the English Language Learners. English Language Learners are a priority because the group tends to be the lowest performing. The first LCAP Goal 1 Action 3 includes intensive tutoring to support the CSI plan. DVE expects to see the graduation rate improve. The second goal is a broad goal supporting student interest in a career or higher education. DVE expects to see the ELA and math indicators improve by 1 level. The third goal is a maintenance of progress goal that meets the mission of the school program to retain students and help them graduate. DVE expects the success rate to be above 80%. The last LCAP goal is to improve educational partner engagement, especially for unduplicated students and their families. DVE hopes to increase survey completion and results over time.

DVE is a single-school LEA with Dashboard Alternative School Status. Below is a summary of how the school developed the Comprehensive Support and Improvement Plan. With guidance and training from the CDE, the county, and the local professional network, the following was done:

• DVE assigned the Director of State and Federal Programs to lead the school in conducting a needs assessment by analyzing the 5-year cohort graduation data to identify gaps and inequities between the highest student group and the other groups. The results are described in the Identified Needs section in the LCAP Plan Summary. The framework was Carnegie's Improvement Science, and the model is the Plan-Do-Study-Act process for continual improvement.

• The type of data collected for the needs assessment was CA Dashboard, math, ELA, and graduation results, attendance data, tutoring participation data, and credit completion data.

• The data informed the CSI plan by guiding the root cause analysis towards tutoring as a viable research-based strategy to increase math skills, credit completion, and graduation rates. The data revealed that students who participated in tutoring had 50% more credits completed than those who did not. As a result, Goal 1 Action 3 in the LCAP provides for tutoring.

• The educational partners were engaged in the process through meetings held by leadership, sharing the data, and eliciting feedback from the PAC and ELAC meetings, staff, and student groups. The discussions centered on equity for all students regarding learning expectations, obstacles to achieving their potential, and access to quality materials and instructional support such as tutoring. Additionally, as a professional network of DASS independent study schools, DVE reviewed graduation data using the fishbone protocol. The fishbone helped to reveal the root causes. A deeper dive was done with the admin team around credit completion and resource inequities to help frame the analysis. The educational partners were engaged through the PAC and ELAC meetings and staff in analyzing the data. The discussions led to supporting Goal 1 Action 3, which is assigning tutoring for students as the means to improve the graduation rate.

Evidence-Based Intervention - Intensive Tutoring

The Director of State and Federal Programs supported the school by leading the principal team through the needs assessment and identifying evidence-based strategies. The principals then led the staff through the selection of evidence-based strategies at their staff meetings.

The process for matching the selected intervention with the identified need was a collaborative endeavor through the professional network. DVE met regularly to study the data. From the needs assessment, DVE saw that those who attended tutoring earned 50% more credits, and the school believed that tutoring could potentially close credit completion gaps. DVE then investigated other best practices for improving graduation.

With guidance from CDE and county offices, DVE searched out solutions to improve the graduation rate, and we were guided to the following evidence-based research. During a randomized controlled trial, math tutoring research showed 2,718 African American or Hispanic males in the ninth and tenth grades from the south and west sides of Chicago an increase in math scores from 0.19 to 0.31 and an increase in math grades by 0.5. Of the students, 90% were on free and reduced lunch programs. (Nickow, Oreopoulos, Quan, 2020).

The rationale for selecting the intervention is based on three main components. First, the students need to improve their math skills, which inhibits their ability to earn credits toward graduation. Second, education research points to intensive tutoring as a viable means to increase math performance, which will increase credit completion. Third, increasing a student's capacity to earn credits through intensive tutoring will yield higher graduation rates.

The administrative team and educational partners selected the following research-based strategies to implement:

\* The school will provide one-on-one intensive tutoring.

\* The school will provide positive social incentives for good attendance.

- \* The school will track specific data for the senior cohort.
- \* The school will continue seeking educational partner involvement and input.

DVE will address the low performance in graduation, ELA, and math, by assigning tutoring to students who demonstrate low scores as determined by their NWEA diagnostic assessment results. The low scores reveal inequities that must be resolved through the implementation of the plan.

Resource Inequities Analysis

The Director of State and Federal Programs guided the school through a resource inequities analysis. The analysis showed that more funds should be allocated to LCAP Action 1 Goal 3 because the following groups had significant gaps in graduation rates. Every student group was below the African American student group in their 4-5 year graduation rate. There was a significant difference of 7 percentage points for the Hispanic and English Language Learners compared to All student groups. Additionally, the socioeconomically disadvantaged, English Language Learners, and Hispanic students had a gap of 3-7 points from the highest student group. The data shows that there are inequities in performance, and the LCAP, with its CSI plan, is designed to address them in a comprehensive manner.

DVE is a single-school LEA charter school. The Director of State and Federal Programs provides support by discussing resource inequities and will increase funding toward LCAP Goal 1 Action 3. The guiding framework was from The Alliance for Resources Equity at www.educationresourceequity.org. Leadership also used the Dimensions of Resource Equity – School-level Diagnostic Questions to determine key resource levers that create equitable learning experiences for all students.

Additionally, the inequities rubric, provided by the Los Angeles County Office of Education, was used to help identify if there were any barriers to the following:

- Access to Highly Qualified Teachers
- Access to Counselors
- Access to Student Retention Services
- Access to Tutors
- Access to interventions both social-emotional and academic
- Access to incentives for attendance, graduation, and retention
- Access to support for high needs English Language Learners, foster youth, special education, homeless
- Access to technology and instructional materials

The resource inequities are being addressed by increasing the funding in LCAP Goal 1 Action 3 for intensive tutoring. LCAP Goal 1 Action 3 provides funding for tutoring support. Students are identified for tutoring based on NWEA diagnostic assessment results and teacher referrals. Tutors connect with students daily and provide academic support in math and other subjects to help them earn credits toward graduation.

All students receive a personalized academic learning plan that is unique to each student and specifically designed to create an optimal path toward graduation. The independent study model assigns a supervising teacher to each student, who develops a close relationship with the student, supports the student from enrollment to graduation, and brings in resources and support staff as needed.

Foundation for the Advancement of Teaching (2015). When frequently done and in collaboration with leadership, the Plan, Do, Study, Act (PDSA) model will help the school improve its outcomes on multiple metrics. With leadership, a Fishbone protocol was used to determine the root causes behind the conditions and drivers that lead to the graduation rate. The fishbone helped define the problem. The discussion focused on what changes were needed and why. The plan is to collect and share data regularly around credit completion, attendance, and senior graduation progress to help answer the question: "How will we know which change is an actual improvement?"

The Six Principles of Improvement from the Carnegie Foundation helped provide a foundation for our analysis:

1) Make the work problem specific and user-centered: What specifically is the problem we are trying to solve?

2) Variation in performance is the core problem to address: What works, for whom and under what set of conditions?

3) See the system that produces the current outcomes: What are the drivers that yield change?

4) We cannot improve at scale what we cannot measure: What are the key outcomes that track progress?

5) Anchor practice improvement in disciplined inquiry: How will we engage in rapid cycles of Plan, Do, Study, Act (PDSA)? "How will we know which change is an actual improvement?"

6) Accelerate improvements through networked communities: How can we accomplish more together?

These guiding principles will be utilized with leadership throughout the year as we meet to discuss progress and next steps.

#### Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

The Director of State and Federal Programs will support the school team and work with them to monitor and evaluate their improvement plan's effectiveness throughout the school year.

The process, including metrics, used for monitoring the implementation of the CSI plan is that the Director of State and Federal Programs will collaborate with the school team to collect tutoring participation and share it with teachers and school leadership.

The process, including metrics, used for evaluating the implementation of the CSI plan is to pull tutoring participation counts every learning period and determine if there is an increase in those who have received tutoring. The target is to increase tutoring participation by 50% at the end of the 7th learning period.

The process, including metrics, used for monitoring the effectiveness of the interventions to improve student outcomes is to pull and analyze credit completion for all students who participated in tutoring at the end of each learning period.

The process, including metrics, used to evaluate the interventions' effectiveness is to analyze the credit completion data. The target for the credit completion rate is 4.0. Additionally, the school expects graduation rates to increase by at least 1% each year.

Additionally, we will collaborate with the professional learning community groups and implement the Plan, Do, Study, Act (PDSA) model as the process for continuous improvement. Through the PLC process, the school will use tutoring participation, credit completion, attendance, and graduation data to inform results. By monitoring our evidence-based interventions, we can see how seniors and others utilize one-on-one tutoring and incentives for increased attendance. The school will also monitor NWEA results to identify the needs of struggling students.

The measure of success for the plan is based on key indicators such as credit completion, attendance, and tutoring. The DASS one-year graduation rate and the federal 4-5 year graduation rate. Students are monitored closely by their teachers and counselors, especially seniors. The school plans to monitor students early and often to meet student needs proactively.

The Comprehensive Support and Improvement Plan results will be reported to teachers, students, parents, and the school board. Progress on the CSI plan will be reported at least twice a year. Feedback from the PAC and ELAC will be garnished after CSI data is presented. The governing board will receive ongoing CSI student data to garnish feedback. Data reports can routinely be shared with all educational partners.

## **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

DVE received Title I funds and uses the LCAP as the School Plan for Student Achievement (SPSA). DVE is adhering to federal guidelines for involving the educational partners in the Title I Program Evaluation, and gathered input for the use of the federal funds. DVE held Title I meetings on September 7, 2022, November 16, 2022, March 1, 2023, and May 10, 2023, where student achievement and performance gaps were discussed. Families were informed how federal funds could help improve the academic achievement of English performance schoolwide by implementing a well-rounded instructional program to meet the educational needs of all students. Throughout the year, DVE met to discuss student needs and how the funds could be appropriately directed to help improve student performance. Educational partner feedback was incorporated into this LCAP.

DVE used various methods to solicit feedback from all educational partner groups. Educational partner groups included parents/guardians, community members, students, classified and certificated staff, site leadership, and the governing board. DVE held several different types of meetings to engage the educational partners throughout the school year, including PAC/ELAC meetings, awards nights, parent-teacher conferences, classified and certificated staff meetings, surveys, workshops, and community events. In addition, DVE shared progress on each LCAP goal, the actions taken to implement the goal, and evidence to show progress towards meeting the goal/target. The leadership team reviewed metric data aligned with each LCAP action and goal to determine if progress was being made toward achieving the desired outcome. As data became available locally and through the state (Dashboard data), meetings were held to review, analyze, and disaggregate data to determine areas of need and success. More importantly, DVE distributed surveys to solicit feedback to determine needs and barriers to success. DVE identified and developed opportunities for students and families to become more engaged in the school community by working with the community liaison. DVE has no Certificated or Classified bargaining units.

Parent Advisory Committee (PAC) 5/10/23 Meeting to review the Comprehensive School and Improvement Plan, Annual Title I Data, and the LCAP was shared including the data, goals, and actions that describe where the funding is directed in order to improve our students' performance.

English Language Advisory Council (ELAC) 5/10/23 Meeting to review the Comprehensive School and Improvement Plan, Annual Title I Data. Additionally, they were informed about the LCAP data, goals and the actions that direct funds towards services supporting our English Language Learners.

In May 2023, a draft of the LCAP was posted on the school website for two weeks and made available for public comment. The public was provided the opportunity to call or email the principal and provide their input during this time. No input was received.

DVE had our public hearing on June 5, 2023, and our school approved our Local Control and Accountability Plan on June 5, 2023. Copies of the LCAP were available online, prior to the meeting, along with the board agenda. Educational partners were given the opportunity to provide comments to the charter school board, prior to its approval. The Local Indicators were also presented at the same board meeting that the LCAP was approved. The Board adopted the budget at the same meeting as the LCAP Adoption.

- The El Dorado Charter SELPA requests the participation of parents of students with disabilities in the SELPA Community Advisory Committee (CAC).
- The SELPA Program Specialists were provided a copy of the LCAP for consultation on the alignment of LCAP activities with the annual assurances support plan.

A summary of the feedback provided by specific educational partners.

The following aspects of the LCAP will continue due to educational partner support via verbal and written feedback:

- Discussions during PAC/ELAC revealed the importance of having all goals and actions continually monitored and shared.
- Parents/guardians, PAC/ELAC, and classified and certificated staff see the value of continuing to maintain the broad goals since they capture specific actions intended to provide services to all students and provide direct services to unduplicated student groups.
- There will be a continued focus on Goal #1: Increase Academic Performance.
- Students would like to see an increase in dual enrollment courses.
- Resources will be allocated to address the social-emotional issues for students to become more college and career ready.
- Student groups expressed the value of increasing the social-emotional support and strategies for increasing motivation towards graduation.
- Parent surveys show there is a need to increase the communication from school to home about small group instruction classes.
- Student surveys show there is an interest in completing a variety of CTE courses.

DVE will continue to collaborate with the educational partners throughout the school year to explore and monitor the progress of the LCAP goals and actions.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

As a result of sharing the LCAP Data Report with the educational partners and receiving their input, DVE will implement the following goals and direct funds accordingly within the plan. Specifically, parents/guardians from the PAC/ELAC expressed how important it was for their students to access college and career planning workshops. As a result, funds were increased for Goal 2 Action 1 (Students will gain skills for college or career-readiness). Students, parents/guardians, and classified and certificated staff all communicated the importance of students acquiring and demonstrating college and career skills, as evidenced by engagement in college-level courses, participation in CTE coursework, and the ability to navigate technology platforms. Teachers and classified staff expressed how important attendance and retention were for the students, so funds were increased for Goal 3 Action 1 (Increase Student Retention). In addition, parents/guardians and classified and certificated staff all communicated the need to eliminate barriers to student retention in the program. Transportation funds were increased in Goal 3 Action 3 to improve attendance. Funding decisions directly correlate to the needs and concerns raised by educational partners, including school leadership, in accordance with the school's mission.

DVE added an action to Goal 1 to support the learning needs of students in the Title I program. With consultation from educational partners, federal funds were directed towards additional tutors/paraprofessionals to support the implementation of Title I to improve student performance on the CAASPP. DVE shared low-income students were underperforming in math and English Language Arts.

Students specifically asked for increased resources to meet social-emotional needs, additional 1:1 extended academic support, and transportation needs. An increase in funding was added to Goal 1 Action 2 for tutoring and Goal 1 Action 4 for social-emotional support from counselors and other service providers. Transportation was increased in Goal 3 Action 3 to increase unduplicated student attendance.

DVE utilizes a variety of local metrics other than the statutorily required metrics that are meaningful to the program. For example, DVE uses credit completion to measure student progress in course completion. DVE also has a retention rate that measures if a student remains enrolled or returns to their district of residence. DVE has a success rate that measures the retained and successfully graduated students. DVE expects the success rate to be above 80% each year.

Graduation rate and methods to improve the graduation rate were put forth to educational partners at staff PLC meetings, Parent Advisory Committee (PAC) meetings, and English Learner Advisory Committee (ELAC) meetings. Conversations between school staff (including counselors, social workers, and student retention support staff), students, and educational partners are held on a continual basis. Senior events and information nights are held throughout the year to seek input directly from students and parents of students who are close to

graduating. Additionally, the school will gather input from annual parent and student surveys as well as student graduate surveys and exit surveys. Input gathered from Educational Partners include the following:

- Parents at the ELAC and PAC meetings discussed the CSI status and supported the plan to increase tutoring supports, to help improve the graduation rate. This input is reflected in Goal 1 Action 3.
- Parents find senior parent meetings and events to be valuable and would like to continue having them on a regular basis, multiple times annually.
- Parents find the one-on-one support from teachers and counselors important and beneficial and would like more opportunities for weekly for one-on-one counselor support.
- Parents like that their students are receiving college and career support, including support with financial aid and resume building.
- Parents appreciate the community resources offered to their students.
- Students suggested that an increase in tutoring would be appreciated and could helping improve the graduation rate. In the CSI plan and in Goal 1 Action 3, their consultation has been included in the action for tutoring supports.
- Students find value in goal setting and personalized learning plans.
- Staff (teachers and classified) provided input into the CSI plan and agreed that an increase in tutoring would be a good idea. Their support for tutoring is a reason why Goal 1 Action 3 is written into the LCAP.
- Staff appreciate the tracking and support of seniors by the counselors and social workers.
- Staff appreciate the collaborative team approach to support seniors.
- Staff would like to see a formalized process to support seniors after graduation.

	This is a focus goal for increasing the academic progress for all students, especially the English Language Learners, low- income, and foster youth students who struggled over the last year. In the next three years, DVE will have mitigated the learning loss and the school will see improvements in the NWEA, EL reclassification, credit completion, and graduation rates.

An explanation of why the LEA has developed this goal.

As a result of our CSI status and our analysis of key state and local data, DVE has determined the need for a focus goal on academic performance for all English Language Learners, low-income, and foster youth students. This new goal specifically addresses low-key metrics such as the English Language Learner reclassification, credit completion, and graduation rates for the student groups. Reviewing the student data revealed performance gaps between the "All Student Group" and the English Language Learner, low-income, and foster youth students. Each year academic growth is measured using the NWEA MAP assessment. Using the NWEA MAP assessment this year revealed performance gaps amongst student groups. DVE understands the gaps that need to be closed for the students, and this focus goal was carefully designed to support the students' academic needs with targeted interventions and tutoring.

Educational partners were consulted and involved in the LCAP process, which promotes positive engagement, buy-in, and trust. The school knows that additional tutoring, interventions, and counseling support will help address the learning loss over the next few years.

Overall, DVE was able to implement the actions in this goal and there was no substantive difference in planned actions and actual implementation of these actions.

Action 1 - English Learners support staff, interventions, and materials: Upon reviewing the local and state assessment data by subgroup, DVE has identified achievement and performance gaps and programmatic/instructional needs for the English Language Learner student population. The English Language Learner students show the most opportunity for continued academic improvement based on the most current state and local ELA and math data as reflected in the metric tables. Based on a local needs assessment, DVE has found that the English Language Learner students need additional support and scaffolds to be successful. DVE will address this need by providing an ELL paraprofessional or other trained bilingual support staff such as ELL tutors, ELD Leads, and ELD Small Group Instructors. In addition, supplementary materials for the ELD program will be provided as needed. The school was able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions.

Action 2 - All academic interventions and program materials: We implemented this action. As demonstrated in the Identified Needs and Metrics sections, state and local assessments in ELA and math indicate that some of the lowest-performing students are the English Language Learners, low-income, and foster youth student groups compared to the "All Student Group". DVE will provide English Learners, low-income, and foster youth studentic interventions such as small group instruction and intervention classes to improve their academic skills and accelerate their academic achievement. These actions have effectively increased students' mathematics and reading assessments and their NWEA scores. DVE expects all students with low proficiency scores to benefit, making this action schoolwide. DVE

Overall Successes: Our school was able to Overall, DVE was able to implement the main components of the actions in this goal. Essential academic interventions were implemented for the students with the highest needs, including intervention programs and additional tutoring support. Tutors/paraprofessionals provided on-site and virtual support to students to improve their credit completion efforts.

Overall Challenges: Our school was challenged by DVE was challenged at times, with not being able to quickly fill staff vacancies. The school was challenged by supporting students to transition back to fully in-person learning while addressing trauma, social-emotional concerns, and learning loss.

There were no material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services; actual expenditures were approximately the same as budgeted expenditures and principally directed toward the English Language Learners, low-income and foster youth students. DVE met the budgeted expenses in the 2022-2023 Contributing Actions Annual Update table for estimated actual expenditures. This is true for the LCFF funds. There was a positive material difference, due to the actual allotment of \$60,629 in Title 1 funds, which were used to support actions in Action 7.

#### An explanation of how effective the specific actions were in making progress toward the goal.

Overall, the combined 8 actions of this goal have increased the academic progress of our students as measured by key metrics such as the graduation rate, credit completion rate, and English Learner reclassification rate (or use NWEA). As shown above, in the Measuring and Reporting Results chart, the graduation rate remained high at 86.3%. This is the result of a comprehensive and strategic approach to helping students complete their coursework and earn credits towards graduation. Our intervention programs and tutors were able to help us realize a 21% increase in our credit completion rate. We are constantly focused on helping our English learners and their reclassification rate improved. Although our ELPI showed low growth, we are constantly focused on helping our English learners and their reclassification rate improved. The improvement shown in EL reclassification, credit completion, and the graduation rate show that we met our goal for increasing academic progress.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As a result of reflection on prior practice, and due to our CSI status, we selected intensive tutoring as our research-based strategy for our CSI plan, and it is reflected in Action 3. Other changes were that there was no calculation for the English Learner Performance Indicator for 2021, so we reported ELPAC Levels 1-4 as a placeholder, to show that we are examining the data that is available for our English learners. This year we have the 2022 ELPI results, and the levels were removed. We will continue to report the ELPI as it becomes available on the CA Dashboard. Second, we were reporting RIT scores for NWEA Reading and Math results, and now we are reporting Lexile scores for reading and quantile scores for math, because that aligns with how scores are reported at a national level. We did this in order to be more comparable with other DASS schools.

#### An explanation of how effective the specific actions were in making progress toward the goal.

We effectively implemented our College and Career-Readiness goal, as measured by key metrics, such as participation in CTE and Professional Skills courses, a standards-based curriculum, and the California Assessment for Student Performance and Progress. Our English Learners, low-income, and foster youth students were able to engage in activities that focused on career-readiness and/or college readiness. Professional skills courses had an enrollment of 644 this year. 100% of our students had access to a broad range of courses. The results from last year's CAASPP test was 24% in ELA, 8% in science, and 3% in Math. We were able to implement our college and career-ready, standards-based instructional program this year. Additionally, we ensured that students had access to technology and a high level of connectivity in order to support their learning efforts.

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
